**ORDER**

This cause coming to be heard on the 307(d) Petition filed by "CPD," the 307(d) Petition filed by The Latin School of Chicago, and the 307(d) Petition filed by "POP." Responses having been filed by "CPD" and The Latin School of Chicago to the petition filed by "POP", and responses having been filed by "POP" to the petitions filed by The Latin School of Chicago and "CPD." Due notice having been served and the Court being advised in the premises;

**IT IS HEREBY ORDERED** that after consideration of the 307(d) Petitions and Responses submitted in the three above-referenced consolidated cases, this Court vacates and reverses the portion of the April 25, 2008 Temporary Restraining Order which allowed The Chicago Park District and The Latin School of Chicago to complete the construction of an artificial turf soccer field at South Field in Lincoln Park, including the field itself, landscaping, fencing on one side of the field, drainage, pathways, and a drinking fountain, and remands this case to the Circuit Court of Cook County, Illinois, with directions that the Circuit Court enter a Temporary Restraining Order enjoining The Chicago Park District and The Latin School of Chicago from any further construction, excavation or construction related activities at the Latin Facility until further Order of the trial court.
